HUGGS has participated in Overdose Awareness activities, and supports the QFC training about suicide prevention available through Tillamook Family Counseling. Currently in the works for teens are a monthly after school craft event at the Heart of CARTM in Wheeler, and plans for monthly movie nights as well as a teen zine club; a community grief support group/network, and memorial benches in local parks with suicide prevention messaging. The Tillamook Estuaries Partnership (TEP) is a part of 28 National Estuary Projects working throughout the continental United States and in Puerto Rico to protect and restore the health of estuaries while supporting economic and recreational activities. In 1994 Tillamook Bay was designated as a "Bay of National Significance" subsequently leading to the establishment of the Tillamook Bay National Estuary Project. Since its initial formation, TEP has expanded its project area to include all of the bays and watersheds in Tillamook County. Working diligently with its many partners, TEP implements and monitors its Comprehensive Conservation and Management Plan (CCMP) aimed at addressing some of our bays' biggest challenges: loss of key fish and wildlife habitat, decreasing water quality, increased erosion and sediment deposition, and the increasing magnitude and frequency of flood events.

In early fall the PCDA hosted a community cleanup day which included a beach cleanup of the traditional dory beach adopted through SOLVE, removing dozens of wheelbarrow loads of sand from the curbs, sidewalks, and observation deck at the Cape Kiwanda parking lot, trimming back beach grass as well as weed removal from the area. The group of 20 PCDA supporters then moved to the Kiawanda Community Center to install the Chief Kiawanda sign that we rebuilt in the previous week after it had sustained wind damage and cleaned the gutters on the building.
